What are Community Foundations?

Community Foundations are tax-exempt public charities serving thousands of people who share a common interest – improving the quality of life in their communities. Individuals, families, businesses, and organizations create permanent charitable funds that help their region meet the challenges of changing times. The foundation invests and administers these funds to address the core issues in each region. The Northern Piedmont Community Foundation is in compliance with the National Standards for U.S Community Foundations, philanthropy's most rigorous standards.

Top Ten Reasons

to Establish a Fund at Northern Piedmont Community Foundation

- 1. **IT'S EASY**. Your fund agreement spells out all the details. You can recommend grants after you make your first contribution to your fund.
- 2. It's ANONYMOUS. (if you want it to be).
- 3. **IT'S FAMILY-FRIENDLY**. A donor-advised fund allows you to strategize with spouses, siblings, children, or grandchildren to establish your family legacy.
- 4. **IT'S FLEXIBLE**. Enjoy the ability to contribute appreciated assets into an NPCF fund.
- 5. **IT'S MAXIMUM BENEFIT.** A gift of cash to an NPCF fund allows the maximum charitable deduction, up to 50% of a donor's Adjusted Gross Income.

- 7. **IT'S FAIR.** Deduct gifts of closely held long-term appreciated stock at its fair market value, up to 30% of AGI.
- 8. **IT'S EXCISE-TAX FREE**. No tax on investment income here, a benefit of NPCF's public charity status.
- 9. **IT'S PEACE OF MIND.** When you give through NPCF, you can be assured that the grants you make support nonprofits that meet our stringent requirements.
- 10. **IT'S GOOD SERVICE**. Best of all, you have the expertise of the Community Foundation staff to support all your giving and granting needs.

For the third year in a row, the Northern Piedmont Community Foundation hosted the annual Give Local Piedmont campaign. Despite technological issues that brought down the website for the entire day, donors, nonprofits, volunteers, and staff worked together to achieve the most successful Give Local Piedmont yet!


We surpassed our personal goal of \$800,000, and ended the event by raising over \$883,000 for nonprofits in a four-county area. Our nonprofits did a fabulous job of keeping donors informed and our donors made sure, despite all the difficulties, that they supported their causes.

Some of the big winners for the 2016 campaign were:

- Fresta Valley Christian School: \$109,697 top prize winner
- Highland School had 410 unique donations
- Finley's Fund reached 15 states and 4 different countries
- 19 states participated
- 1,228 first time Give Local Piedmont donors
- Over one half of the participating nonprofits serve two or more counties
- Rapp Cats \$12,102 (Grow the Grassroots Prize)

In addition to the money raised, the PATH Foundation's (formerly Fauguier Health Foundation) \$100,000 bonus pool provided additional funds for all nonprofits. These funds were distributed according to the amount each organization raised. This is the third year PATH has partnered with Northern Piedmont to make this program a success. Along with the bonus pool, Northern Piedmont also granted \$30,000 in prizes through generous businesses, individuals and fund sponsors. The sponsorships for prizes represent an admirable collaboration of our community. The PATH Foundation spearheaded a Youth and Philanthropy initiative introducing our high school seniors to nonprofits and the work they accomplish. Students were asked to support nonprofits of their choice with \$25 (provided by the PATH Foundation). This collaboration helped young people better understand how our communities work and gave them a first hand experience in supporting causes they care about; plus it created increased resources for our nonprofits.

Without the wonderful people who live in the Culpeper, Fauquier, Madison, and Rappahannock communities and beyond, none of this would have been possible. We extend our heartfelt thanks for your participation, and look forward to next year's campaign on May 2, 2017!

Award amounts generally range from \$500 to \$5,000. Grant application due February 15.

Patricia and Nicolaas Kortlandt
Memorial Fund invites proposals for
projects that strengthen the fabric of
Fauquier County and that represents
the diverse interests of Patricia and
Nicolaas Kortlandt. The Kortlandts
were community-minded people
who lived in Fauquier County for over
50 years and supported Fauquier
through their farm and service to
civic organizations and schools. They
were adamant volunteers. This fund
Award amounts generally range from
\$500 to \$10,000.
Grant application due July 15.

Now & Forever Fund is a community endowment set up by Northern Piedmont Community Foundation to support the changing needs of nonprofits in all four counties. Open application.

Richard Lykes Rappahannock
Community Fund is focused on improving the quality of life in Rappahannock County. A bequest from long-time Rappahannock resident Richard Lykes enabled the Northern Piedmont Community Foundation to create the Richard Lykes Rappahannock Community Fund. Award amounts generally range from \$500 to \$10,000.

Gordon Thornhill Excellence in Youth Foundation Fund supports nonprofit organizations for sports and agriculture related enrichment projects for the youth of Rappahannock County. Award amounts generally range from \$500 to \$5,000. Grant application due October 15.

Culpeper Foundation Fund was orginally designated as a way for citizens to give gifts to meet Culpeper's charitable and educational needs. Awards benefit Culpeper charitiable orgnaizations with amounts from \$500 to \$5000.

Grant application due December 1.
